ABOUT MARSHALLTOWN WATER WORKS

ESSENTIAL FUNCTIONS:

- Safely and effectively performs duties in all aspects and functions of construction, maintenance and emergency repair of water distribution system: installs, maintains and repairs water mains, fire hydrants and valves.
- Responds to water related emergencies such as main breaks; assesses situation, determines proper action, makes process control decisions, performs necessary repair work to resolve problems or requests appropriate support needed to resolve problems.
- Performs valve and hydrant maintenance and inspection.
- Under the direction of the Crew Leader, Distribution Supervisor, or Distribution Manager, operates and maintains a variety of automotive and specialized equipment including backhoe, tractor, vacuum excavator, compressor, hydraulic valve operator, loader, dump truck, pumps and other various hydraulic systems.
- Performs construction inspections to ensure compliance with MWW's standards, plans, and specifications.
- Locates stop boxes, valves, and water mains.
- Completes service taps in compliance with MWW Rules and Regulations.
- Under the direction of the Crew Leader, Distribution Supervisor, or Distribution Manager, conducts new construction water line chlorination, flushing and bacteriological sampling.
- Maintains records related to work performed; tracks, reports, interprets information, follow-up on required maintenance and repair and maintains program documentation.
- Operates power and hand tools such as tamper, jackhammer, electric tools, tapping machines, welders, and other tools as required.
- Participates in the mandatory standby/callout rotation that provides 24-hour coverage of all water distribution components and facilities. Occasionally responds to treatment plant emergencies.

- Follows MWW's safety procedures, obtaining related training and supporting a safe work environment.
- Maintains barricades and other related traffic devices at the job site to ensure safety in the working environment and for the general public.
- Performs property maintenance activities such as lawn mowing, snow removal, and customer property restoration.
- Performs other duties as assigned.

ESSENTIAL REQUIREMENTS:

- Shall possess a valid Iowa driver's license and have a good driving record
- Knowledge of procedures and ability to operate tools and equipment related to water distribution systems
- Two years of construction experience and/or heavy equipment operation preferred
- Ability to prepare daily written reports
- Must be able to respond to emergency calls within 15 minutes when called
- Must be able to effectively communicate with customers internal and external
- Basic knowledge of plumbing techniques
- Basic knowledge of the use of hand tools
- Understand and follow oral and written instructions in an independent manner
- Meet the physical requirements necessary to safely and effectively perform required duties including heavy manual labor in adverse conditions over long periods of time
- Establish and maintain effective work relationships within a team-oriented operation

ESSENTIAL PHYSICAL DEMANDS:

- Ability to handle up to 100 lbs. and lift 50 lbs.
- Ability to work in confined spaces.
- Ability to climb and descend ladders.
- Ability to squat, bend over, and kneel for extended periods of time.

ENVIRONMENTAL CONDITIONS:

- Frequent exposure to traffic and machine noise.
- Frequent exposure to adverse weather conditions.
- Working in excavations with mud and water.
- Limited exposure to hazardous chemicals.

All job requirements listed indicate the minimum level of knowledge, skills, and/or ability deemed necessary to perform the job duties, responsibilities or requirements.
